

General Rights for All

You have the right to remain silent.

You do not have to answer any questions about your immigration status or anything else.

Do not lie or provide false documents.

This can be used against you later.

You have the right to refuse a search.

If an officer does not have a warrant, you do not have to consent to a search of yourself, your home, or your belongings.

You have the right to an attorney.

You can say, "I want to speak to a lawyer" before answering any questions.

Stay calm and do not resist.

Even if you believe your rights are being violated, resisting arrest can lead to additional charges.

Do not sign anything you do not understand.

Ask for a lawyer before signing any documents.

Hand them a red card.

IF ICE OR LAW ENFORCEMENT APPROACHES YOU IN PUBLIC

- Ask, "Am I free to go?" If they say yes, walk away calmly.
- If they say no, you have the right to remain silent and ask for a lawyer.
- Do not run. This can be used as evidence of wrongdoing.
- Do not consent to a search. You can say, "I do not consent to this search."
- If you are detained, ask for a lawyer immediately. You do not have to answer questions.



IF ICE COMES TO YOUR HOME



 Do not open the door. Ask through the door for them to show a <u>SIGNED</u> warrant from a judge

(if it is not signed, it does not count!!!!
They will try to trick you!)

 If they do not have a valid judicial warrant, you do not have to let them in.

 If they force their way in, say: "I do not consent to this search."

- Record or take notes of badge numbers and names.
- Do not answer any questions without a lawyer.



IF ICE OR LAW ENFORCEMENT APPROACHES A CHILD AT SCHOOL


- Children have the right to remain silent and should not be questioned without a lawyer or parent present.
- If a child is detained, parents or legal guardians should immediately request legal representation.





For Teachers & School Staff

- You are not required to share student information (such as immigration status) unless legally mandated.
- If ICE or law enforcement comes to a school, ask for a warrant signed by a judge. If they do not have one, they should not be allowed in. They may try to trick you and show you an unsigned warrant or document. If it is not signed, it is not valid.
- If a student is approached by ICE, approach them and instruct them to remain silent and request a lawyer.



IF ICE OR LAW ENFORCEMENT APPROACHES A HEALTHCARE WORKER OR HOSPITAL STAFF



- You are not required to disclose a patient's immigration status under HIPAA unless legally compelled.
- If ICE is requesting patient records, ask for a subpoena or court order and call your manager immediately.
- Staff should **not confirm or deny** whether a patient is present.
- If ICE tries to enter, hospital security can ask for **legal documentation**.

IF YOU ARE A PARENT & ICE OR LAW ENFORCEMENT APPROACHES YOU

- Have a family preparedness plan. Ensure someone you trust has legal guardianship documents for your children.
- If detained, tell officers, "I have children who depend on me."
- Do not sign voluntary deportation forms without speaking to a lawyer.
- Do not sign anything that you have not read if that means it needs to be in Spanish, request this. Sometimes they will give you a "lawyer" with paperwork to sign which is really deportation paperwork.
- If your child is taken by law enforcement, request immediate access and legal assistance.



IF YOU ARE A PROTESTER

- You have the right to peacefully protest.
- You do not have to answer police questions if stopped.
- You do not have to consent to a search of yourself or your belongings.
- If arrested, request a lawyer immediately.
- Do not resist arrest, even if you believe it is unlawful.
- If filming, **do not interfere with police activity.** You have the right to record, but officers may confiscate your device if they have a warrant.
